FRASERCOUNSELING CENTER

MISSION

HELEN'S HAVEN CHILDREN'S ADVOCACY CENTER

To reduce trauma of youth in a safe, non-threatening, child-friendly environment for the evaluation of suspected child abuse and to provide supportive healing to the client and non-offending caregivers.

To provide comprehensive, trauma-informed support to all child victims of abuse and family violence and to provide prevention education resources and activities which support the reduction of victimization of children in our community.

FRASER COUNSELING CENTER 2022 IMPACT

The Fraser Counseling Center offers individual, family, and child therapy utilizing a variety of evidence-based treatment modalities. In 2022, we are proud to have offered:

Sessions for 309 clients 2,766 sessions 1,998 school based sessions for 64 students

The vision of Dr. Fraser was to offer treatment and support to all people in need, **regardless of their ability to pay**. Because many of the individuals we treat are either uninsured or underinsured, we have established the Fraser Counseling Center **Hope and Healing Fund to cover the cost of unreimbursed expenses**.

In 2022, the Fraser Counseling Center provided **35 clients with financial assistance, totaling 110 hours of therapy,** from the Hope and Healing Fund to either initiate or to continue treatment.

SUCCESS STORY FROM THE FRASER COUNSELING CENTER

In the fall of 2022, a young man, who we will call Jim to protect his confidentiality, 29 years old, reached out to the Fraser Counseling Center to begin sessions. While in therapy with one of our clinicians, he shared that he was having thoughts of harming himself. He did not have a history of suicidal thoughts or actions.

During the session in which he shared his thoughts, the clinician was able to identify protective factors to ensure his immediate safety and created a plan for him to share with his family how he was feeling. Jim committed to weekly sessions with the therapist who is trained in Dialectical Behavioral Therapy focused on reduced thoughts of self-harm, increasing tolerance for distress, and improvement in mood. At his 4th session, Jim was indicating no thoughts of hurting self on his mood and feeling survey completed prior to each session.

Jim continued in therapy for an additional 8 sessions and was not reporting any mood disturbance on the mood and feelings survey by the last session. The therapist and Jim agreed that he has met his clinical goals. Jim decided to end therapy for now. The therapist and Jim created a safety plan that included returning to therapy if his depression symptoms return or if he has any thoughts of suicide.

The therapist reached out to Jim at the beginning of December 2022 (5 weeks after ending therapy) to check on him. Jim reported continued feelings of hope for the future, enjoyment in his daily life, and connections to his friends and family. Your support and contributions help us help individuals like Jim.



HELEN'S HAVEN CAC 2022 IMPACT

The purpose of Helen's Haven Children's Advocacy Center is to reduce youth trauma in a safe, non-threatening, child-friendly environment. In 2022, we provided **evidence-based services for supportive healing at no cost** to our clients, including:

1,216 therapy sessions 213 forensic interviews 272 children served 190 parents/caregivers served

Additionally, we distributed prevention information to 1,323 children and 1,280 adults



Helen's Haven CAC is proud to uphold Dr. Fraser's vision of services for all individuals and families by offering all of our assistance free of charge. We provide the following for children ages 3 to 17, their non-offending parents, and families:

Crisis intervention
Forensic interviews
Specialized trauma-focused therapy
Medical and community referrals
Trauma and victim assistance

Success Story for Helen's Haven Children's Advocacy Center

An adolescent was referred to Helen's Haven Children's Advocacy Center due to allegations of sexual abuse. Following the forensic interview, the teen's parent requested therapy services for the adolescent as well as for them themself. The parent also had a prior trauma history and was having trouble coping with the abuse experienced by their child.

TF-CBT services were provided to the adolescent victim who met PTSD diagnostic criteria and was experiencing multiple trauma symptoms and self-harming behaviors. During therapy, the adolescent was able to stop self-harming after working on emotional regulation and coping skills. The parent received therapy services to address their own trauma history while also learning techniques to be supportive of their child.


The parent's complex trauma symptoms created additional challenges in coping with the family's situation. The relationship between the parent and adolescent became very strained and challenging due to the dynamics of the experienced abuse and trauma they each experienced. In addition to their individual therapy sessions, they also participated in joint therapy sessions to improve their relationship. The adolescent victim participated in therapy over the course of two and a half years. At the time of completing therapy the adolescent's final trauma assessment score reflected that the adolescent no longer met the criteria for PTSD.

The parent participated in individual therapy sessions for approximately three years prior to completing therapy services at Helen's Haven CAC. The relationship between the adolescent and the parent improved dramatically over the course of therapy, and trauma symptoms were reduced significantly for both the adolescent and the parent.

In total, the adolescent victim and the parent received approximately 170 hours of no cost trauma-informed and evidence-based therapy services as well as other support and victim advocacy services from Helen's Haven Children's Advocacy Center. Your support and contributions help us continue to support other families like this one.




2022 FRASER COUNSELING CENTER REVENUE




TOTAL: \$438,965

2022 FRASER COUNSELING CENTER EXPENSES




TOTAL: \$456,599
